The Bidders are expected to go through all instructions, terms & condition as specified in the bidding document. Failure to furnish complete required information or submission of a bid with incomplete information may result in rejection of the bid.

GENERAL TERMS & CONDITIONS

- 1. The Bidders are required to submit the sample(s) of the matting and foam. No Tender shall be considered without sample(s).**
- 2. The Tender/financial bid of only those bidders shall be opened whose sample are selected by the Committee.**
- 3. The bidders shall have to submit the samples in a separate envelop.**
4. The tender duly completed and signed shall be submitted in a sealed cover. The sealed cover upper-scribed “**Short term tender notice for supply and fixing of Loop Pile Graphic Matting and Foam**” shall be addressed to the **Assistant Registrar (Procurement & Stores)** Islamic University of Science and Technology, Awantipora Pulwama and shall be submitted on or before **21-01-2022 (2.00 pm)**.
5. The intending bidders shall have to paste transparent tape on the rates quoted by them in Indian Rupees (INR) only both in figures and in words **FOR IUST Stores Awantipora**, inclusive of supply, fixing and all charges/taxes including GST. In case of a discrepancy, the amount quoted in words will be taken as final.
3. The Tender should be accompanied with **Earnest Money Deposit (EMD) of ₹ 20000.00** (Twenty Thousand only) in the shape of FDR/CDR of any nationalised Bank drawn in favour of “Islamic University of Science and Technology”, payable at Awantipora, Pulwama (J&K).
4. The tender submitted shall remain valid for a period of **90 days** from the date of opening of the bid.
5. The rates will remain valid for supply of flooring till 31st March, 2022.
6. The supply, transportation etc. of the items will be sole responsibility and at the risk of the firm till the acceptance by the University.
7. The flooring supplies made under this tender notice will be inspected by a Committee specially constituted for the purpose and in case the Committee is of the opinion that the supplies are not of the required specifications, the supplies shall be rejected and responsibility of lifting back the supplies will devolve on the supplier. Besides, in such event, the EMD shall stand forfeited and the extra cost incurred in arranging the supply from the alternative sources shall also be recovered from the defaulting supplier apart from initiating the proceedings for blacklisting.
8. The University reserves the right to reject or accept any Proposal without assigning any reason or cancel or withdraw the tender. The University reserves the right to relax any condition enumerated or arising out of this tender, without assigning any reason/s thereof. If the supply of the required items are not affected before the specified period, the University shall have the authority to cancel the order or to take any action deemed fit in the circumstances.
9. In case of any dispute the jurisdiction will be courts at Srinagar only.
10. The EMD may be forfeited:
 - (a) If a Bidder withdraws its bid during the period of bid validity.
 - (b) If at any stage it is proven that the information given by the bidder is incorrect.
 - (c) In case of a successful Bidder, if the Bidder fails:
 - to execute the supply within the stipulated time.
 - if the items are not as per the specifications.
11. The University may, for any reason, whether suo-moto or in response to a clarification requested by a prospective bidder, modify the bidding documents by an amendment, any time prior to the last date for submission of bids.
12. Tenders received after due date, improperly sealed, or with incomplete marking or with overwriting/corrections are liable to be rejected.

13. During evaluation of bids, the University may, at its discretion, ask the Bidder for a clarification of its bid. The request for clarification and the response shall be in writing and no change in prices or substance of the bid shall be sought, offered or permitted.
14. Failure of the successful bidder to comply with the requirements of the University shall constitute sufficient ground for the annulment of the award and forfeiture of the bid security, in which event the University may make the award to the next lowest bidder or call for new bids.
