Provisionally selected candidates are advised to report to the Office of the Deputy Registrar Admissions, Islamic University of Science & Technology (IUST), Awantipora from **25<sup>th</sup> to 27<sup>th</sup> of October, 2017** along with all the relevant documents in original and the requisite fee to be deposited in J&K Bank Ltd, IUST Campus, Awantipora.
3. The candidates shall have to submit an Affidavit duly attested by 1<sup>st</sup> Class Magistrate/Public Notary to the effect that s/he is neither on the rolls of any institution nor employed in any Government/Semi Government Department.
4. The female candidates provisionally selected shall have to submit an undertaking to the effect that they are un-married as on date.
5. The candidates in the **Waiting List** are advised to report (in person) to Deputy Registrar Admissions from **25<sup>th</sup> to 27<sup>th</sup> of October, 2017** along with an application and a Caution Fee of **Rs. 34,200/-** (Thirty Four Thousand and Two Hundred Rupees only) in the shape of Demand Draft favouring Islamic University of Science & Technology payable at J&K Bank Ltd. IUST Campus, Awantipora for admission in case of any available vacancy (ies), **failing which it shall be presumed that they are not interested to take Admission at IUST and accordingly the seat shall be allotted to the next candidate as per the merit and preference.** The Caution Fee shall be adjusted in the total fee in case the candidate is admitted or the same shall be refunded if the candidate is not admitted.
