INSTRUCTIONS FOR TUITION FEE WAIVER SCHEME

- The candidates whose parental annual income is less than **Rs. 6.0 lakhs** from all sources shall only be eligible to apply under this scheme. In this regard, a certificate from concerned Tehsildar as per the prescribed format need to be produced at the time of admission of the candidate.
- The waiver is limited to the tuition fee only. All other fee except tuition fee shall have to be paid by the selected beneficiary.
- In the event of non-availability of students in this category the same shall not be given to any other category of Applicants.
- Only one candidate from a particular family shall be eligible to avail the benefit of Tuition Fee Waiver Scheme.
- The selection under TFW scheme shall be based on the total merit of the student obtained as shown in the merit list available on the university website and income specified above.
- Students admitted under this scheme shall not be allowed to change Institution/Course/Branch under any circumstances.
- Students admitted under TFW scheme have to produce an affidavit at the time of his/her admission from **1st Class Magistrate** to the effect that he/she is not availing any other scholarship. If found otherwise his/her candidature shall be cancelled under TFW scheme.
- The scheme is **NOT** applicable to candidates admitted under **Self Financing** category and **NRI Sponsored quota**.
